

ORDER

Upon consideration of the notice of appeal filed in appeal no. 13-CV-582, and it appearing that no new transcript is needed for appeal no. 13-CV-582, and it further appearing that, in appeals nos. 13-CV-348 & 13-CV-358 appellant's brief has been filed, but the appendix has not been filed with this court, it is

ORDERED, *sua sponte*, that appeal no. 13-CV-582 is consolidated for all purposes with previously consolidated appeals nos. 13-CV-348 and 13-CV-358. It is

FURTHER ORDERED that, in appeals nos. 13-CV-348 & 13-CV-358, appellants shall within 15 days from the date of this order, submit the appendix, accompanied by a motion for leave to file out of time. The motion should set forth good cause for the failure either to timely file the appendix or to request an extension of time within which to do so. Failure to comply with this order shall subject appeals nos. 13-CV-348 and 13-CV-358 to dismissal without further notice. *See* D.C. App. R. 13. It is

FURTHER ORDERED that a briefing order addressing the issues raised in appeal no. 13-CV-582 will be issued upon the filing in this court, by the Clerk of the Superior Court, of the record index in appeal no. 13-CV-582 in accordance with D.C. App. R. 11 (b)(3)(A). It is

FURTHER ORDERED that appellees' consolidated briefs shall be filed within 30 days from the filing of appellant's brief in appeal no. 13-CV-582.
