ORDER APPROVING PAYMENT OF
REHABILITATION FEES AND EXPENSES

On May 12, 2015, D.C. Chartered Health Plan, Inc., acting through its Rehabilitator, Special Deputy to the Rehabilitator and their attorneys (“Chartered”), filed a Notice of Filing by Special Deputy to the Rehabilitator of the Sixteenth Submission of Fee and Expense Statements for *In Camera* Review and Petition for Approval of Payment. The Petition asks the Court to enter an Order approving the payment of Class 1 Administrative Fees and Expenses in the Sixteenth Submission.

On July 27, 2015, Chartered filed a Notice of Filing by Special Deputy to the Rehabilitator of the Seventeenth Submission of Fee and Expense Statements for *In Camera* Review and Petition for Approval of Payment. The Petition asks the Court to enter an Order approving the payment of Class 1 Administrative Fees and Expenses in the Seventeenth Submission.

The Court has reviewed the fee and expense statements *in camera*, together with the cover memorandums submitted with the statements by the Special Deputy to the Rehabilitator. Based on that review, the Court has concluded that the petitions for approval of the Class 1

Administrative Fees and Expenses in both the Sixteenth and Seventeenth submissions should be granted.

FURTHER ORDERED that the following payments in the total amount of \$184,922.65 be and they hereby are approved:


