**ORDER APPROVING RETENTION OF TAX PROFESSIONALS, SUBSTITUTION OF  
SUBROGATION LITIGATION COUNSEL AND DISTRIBUTION OF OCEAN'S  
GENERAL ASSETS**

On October 8, 2014, the District of Columbia, at the request of and on behalf of the Liquidator of Ocean, filed a Motion for Order Approving (1) Retention of Tax Professionals, (2) Substitution of Subrogation Litigation Counsel, and (3) Distribution of General Assets.
