**CONSENT ORDER**

**WHEREAS**, CHRISTOPHER A. LAURIE is a Michigan individual resident insurance producer with a business address listed as Foremost Insurance Company, 5230 33<sup>rd</sup> Street SE, Grand Rapids, MI 49512 and has a Michigan resident producer individual license, number 384026234, that is in good standing;

**WHEREAS**, CHRISTOPHER A. LAURIE is a licensed non-resident insurance producer, License Number 2812738, in the District of Columbia;

**WHEREAS**, CHRISTOPHER A. LAURIE failed to report to the Commissioner administrative action taken against his insurance producer license by the Commonwealth of Massachusetts, Office of Consumer Affairs and Business Regulation, Division of Insurance on November 22, 2006, in violation of D.C. Official Code § 31-1131.17 (a) for which the Commissioner may take disciplinary action pursuant to D.C. Official Code § 31-1131.12(a)(2);


**WHEREAS**, CHRISTOPHER A. LAURIE violated the insurance laws of the State of Alabama in violation of D.C. Official Code § 31-1131.12 (a)(2);

**WHEREAS**, the Commissioner of the Department of Insurance, Securities and Banking (Department), has the authority to place on probation; levy fines, order restitution and take other action against an insurance producer who has violated any provision of D.C. Official Code § 31-1131.12 (a);

**NOW THEREFORE, IT IS HEREBY ORDERED:** That CHRISTOPHER A. LAURIE shall be placed on probation for a period of one (1) year, which shall commence upon the execution of this Order by all parties; and it is

FURTHER ORDERED: That CHRISTOPHER A. LAURIE shall pay a fine in the amount of three hundred and fifty dollars (\$350 00). Payment shall be made by certified check, cashiers check or money order made payable to the DC Treasurer and delivered to the Commissioner, Department of Insurance, Securities and Banking, 810 First Street, NE, Suite 701, Washington, DC 20002, ATTN: Charlotte W. Parker, Assistant Attorney General, Office of Legal Affairs; and it is




