CONSENT ORDER

WHEREAS, DIANE J. LEHNER is an Iowa individual resident insurance producer with a business address listed as 4515 20th Avenue, SW, Suite C, Cedar Rapids, Iowa 52404 and has a Iowa resident producer individual license, number 169762, that is in good standing;

WHEREAS, DIANE J. LEHNER is a licensed non-resident insurance producer, License Number 2838120, in the District of Columbia;

WHEREAS, DIANE J. LEHNER failed to report to the Commissioner administrative action taken against her insurance producer license by the Commonwealth of Massachusetts, Office of Consumer Affairs and Business Regulation, Division of Insurance on November 22, 2006, the State of Alabama, Department of Insurance on May 2, 2006 and the State of Georgia, Office of Insurance and Safety Fire Commissioner on July 10, 2007 in violation of D.C. Official Code § 31-1131.17 (a) for which the Commissioner may take disciplinary action pursuant to D.C. Official Code § 31-1131.12(a)(2);

WHEREAS, DIANE J. LEHNER violated the insurance laws of the State of Georgia, the Commonwealth of Massachusetts, Office of Consumer Affairs and Business Regulation, Division of Insurance and the State of California in violation of D.C. Official Code § 31-1131.12 (a)(2);

WHEREAS, DIANE J. LEHNER and the State of Alabama, Department of Insurance entered into a Settlement Agreement and Order dated May 2, 2006 whereby the 1999 suspension of her license was lifted and she was allowed to apply for a new insurance producer's license;


WHEREAS, the Commissioner of the Department of Insurance, Securities and Banking (Department), has the authority to place on probation; levy fines, order restitution and take other action against an insurance producer who has violated any provision of D.C. Official Code § 31-1131.12 (a);

NOW THEREFORE, IT IS HEREBY ORDERED: That DIANE J. LEHNER's non-resident producer's license, License No. 2838120 is suspended; and it is

FURTHER ORDERED: That the suspension of DIANE J. LEHNER'S non-resident producer's license is stayed; and it is

FURTHER ORDERED: That DIANE J. LEHNER shall pay a fine in the amount of five hundred dollars (\$500.00). Payment shall be made by certified check, cashiers check or money order made payable to the DC Treasurer and delivered to the Commissioner, Department of Insurance, Securities and Banking, 810 First Street, NE, Suite 701, Washington, DC 20002, ATTN: Charlotte W. Parker, Assistant Attorney General, Office of Legal Affairs; and it is

FURTHER ORDERED: That if at any time during the period of the stay of the suspension any violation of the insurance laws or regulations of the District of Columbia or any other jurisdiction shall occur, the stay will be automatically lifted and the immediate suspension of the license of DIANE J. LEHNER will be entered.
