

If you or a family member covered under your health plan is living with a behavioral health disorder or mental illness, knowing the cost of medications can help you make a more informed decision when selecting a health plan.

This guide, developed by the DC Department of Insurance, Securities and Banking ("Department"), provides an overview of several commonly prescribed drugs used to treat depression, anxiety, attention disorders, and other common behavioral health disorders. The chart on the next page depicts the name of each drug, along with the corresponding drug co-payment or coinsurance for each insurance carrier offering plans for sale on DC Health Link in Plan Year 2024.

Each insurance carrier uses different language to explain drug cost-sharing. In order to accurately compare costs and benefits, please reference the chart on the next page alongside the Summary of Benefits and Coverage (SBC) for your potential plan to calculate potential out-of-pocket prescription cost.

As a reminder to consumers, as you compare plans, please reference the SBC to see whether cost-sharing on prescription drugs will apply before or after you reach the annual deductible amount.

The Department is tasked with ensuring access to behavioral health and substance use disorder treatment, including monitoring for parity in the administration of benefits and medication by health insurance carriers. The Department has resources available to assist consumers with access to behavioral health substance use treatment disorder services, including medications. An online form has been made available for consumers to use if they believe an insurance company is administering behavioral health of substance use disorder benefits not in compliance with District and federal law. DC Health Link offers a 'Standard Plan' at each metal level tier for each plan year. Standardized plans are an option that can simplify consumer comparison shopping and bring more value to consumers by offering the same deductibles and cost-sharing across plans. Beginning with the 2024 plan year, the Standard Plans will include treatment of mental health conditions for children 18 and under for \$5 cost-sharing, as reflected in the Pediatric Mental Health Cost Sharing Treatment Recommendation.
