



5. The Department of Insurance, Securities and Banking sent, via certified mail signed by Charlotte Parker, Assistant Attorney General dated July 21, 2008, an Amended Notice To Show Cause IB-SC-24-07, to Respondent Buford S. Foote, c/o AFLAC, 1734 Elton Road, Suite 102, Silver Spring, Maryland 20903 and on August 13, 2008 sent by certified and regular mail notices to 400 Zelma Avenue, Capital Heights, Maryland 20743.
6. The Amended Notice To Show Cause sent to Respondent, directed him to appear before the Department of Insurance, Securities and Banking, Suite 701, 810 First Street, NE in Washington, D.C., on August 21, 2008 at 10:00 a.m.
7. After notice was duly given, a public hearing was held for the purpose of determining whether the license of Buford S. Foote should be revoked.
9. The Respondent failed to appear at the Show Cause Hearing or have a representative appear on his behalf.
10. The Government's (Petitioner's) counsel, Charlotte Parker introduced into the record the following exhibits:


