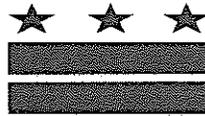

CONSENT ORDER

WHEREAS, Kent C. Lynch is a Florida individual resident insurance producer with a business address listed as 805 Executive Center Drive West, Suite 220, St. Petersburg, FL 33702, and maintains a Florida resident producer license, Number A160799, that is in good standing;

WHEREAS, Kent C. Lynch is a licensed non-resident insurance producer, License No. 1020276, in the District of Columbia with a license that will expire on November 30, 2008;

WHEREAS, the National Association of Insurance Commissioners I Site Regulatory Actions reports that four (4) states have taken administrative action against Kent C. Lynch;

WHEREAS, Kent C. Lynch failed to disclose to the DISB that the jurisdictions of New York, Oklahoma, New Hampshire and Delaware had taken administrative action against him for violating those States' Insurance Laws;

WHEREAS, Kent C. Lynch by his conduct violated D.C. Official Code § 31-1131.17(a) in that he failed to report to the Commissioner administrative action taken against his insurance producer license in another jurisdiction within thirty (30) days of the final disposition of the matter;

WHEREAS, Kent C. Lynch by his conduct violated D.C. Official Code § 1131.12(a)(2) in that he violated insurance laws of the District of Columbia and the jurisdictions of New York, Oklahoma, New Hampshire and Delaware; and

WHEREAS, the DISB Commissioner has the authority to levy fines, order restitution and take other actions against an insurance producer who violates any insurance law pursuant to D.C. Official Code § 31-1131.12 (a).

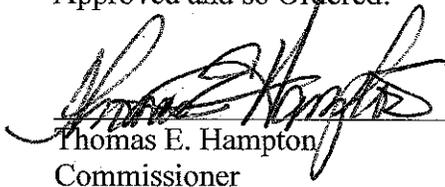
NOW THEREFORE,

IT IS HEREBY ORDERED, that Kent C. Lynch shall be fined in the amount of one thousand two hundred dollars (\$1,200.00) for violating D.C. Official Code §§ 31-1131.12(a)(2) and 31-1131.17(a). Payment shall be made by certified check, cashiers check or money order made payable to the DC Treasurer and delivered to the Commissioner of the Department of Insurance, Securities and Banking, 810 First Street, NE, Suite 701, Washington, DC 20002, c/o Charlotte W. Parker, Assistant Attorney General, Office of Legal Affairs.

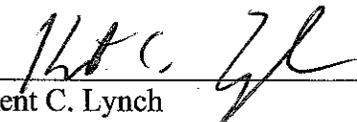

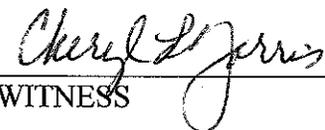
