DEFAULT DECISION AND ORDER OF REVOCATION

The Hearing Officer enters a default decision and order of revocation against Respondent, Marc C. Abrahms based upon the following facts:

1. Respondent Marc C Abrahms is licensed as a non-resident producer authorized to transact insurance business in the District of Columbia.
2. Respondent's non-resident producer license No is AI 0156792.
3. A Notice of Show Cause was sent to Respondent on May 8, 2006 informing him of the charges against him
4. Violation I of the Department's Show Cause Notice alleged that Respondent in the conduct of his affairs under the license No. AI 0156792, violated D.C. Official Code § 31-1131 12(a)(6) whereby he was convicted of a felony
5. Violation II of the Department's Show Cause Notice alleged that Respondent under The license, No AI 0156792, violated Official Code § 31-1131.12(a)(9), whereby he "[had] a producer license, or its equivalent, denied, suspended, or revoked in any state, or territory of the United States. . . ."
6. The Department of Insurance, Securities and Banking sent, via certified mail, dated May 8, 2007, Notice to Show Cause and Official Notice of Hearing IB-SC-06-06, to Respondent at 6 Chesterfield Lane, West Hartford, CT, 06117, Respondent's last known address of record.

7. The Notice of Show Cause sent to Respondent, directed him to appear before the Department of Insurance, Securities and Banking, Suite 701, 810 First Street, NE in Washington, D.C., on June 27, 2006 at 10:00 a.m
8. After notice was duly given, a public hearing was held for the purpose of determining whether the license of Marc C. Abrahms, Respondent, should be revoked.
9. The Respondent failed to appear at the Show Cause Hearing or have a representative appear on his behalf

ORDER

Based upon the record and the foregoing facts, **IT IS HEREBY ORDERED** that a **DEFAULT DECISION IS ENTERED** against the Respondent for failing to appear. **IT IS FURTHER ORDERED THAT** Respondent's non-resident producer's license No. AI 0156792 is **REVOKED**.
