DEFAULT DECISION AND ORDER OF REVOCATION


The Hearing Officer enters a default decision and order of revocation against Respondent, Terrence B Seawright based upon the following facts:

1. Respondent Terrence B. Seawright is licensed as a non-resident producer authorized to transact insurance business in the District of Columbia
2. Respondent's non-resident producer license No. is AI 2821647.
3. A Notice of Show Cause was sent to Respondent on April 5, 2007 informing him of the charges against him
4. Violation I of the Department's Show Cause Notice alleged that Respondent in the conduct of his affairs under the license No. AI 2821647, violated D.C. Official Code § 31-1131.12(a)(9) whereby his license was revoked by another state.
5. The Department of Insurance, Securities and Banking sent, via certified mail, dated April 5, 2007, Notice to Show Cause and Official Notice of Hearing IB-SC-07-02, to Respondent at 1700 Nedro Avenue, Philadelphia, PA 19141, Respondent's last known address of record
6. The Notice of Show Cause sent to Respondent, directed him to appear before the Department of Insurance, Securities and Banking, Suite 701, 810 First Street, NE in Washington, D.C., on May 7, 2007 at 10:00 a.m.

7. After notice was duly given, a public hearing was held for the purpose of determining whether the license of Terrance B. Seawright, Respondent, should be revoked.
9. The Respondent failed to appear at the Show Cause Hearing or have a representative appear on his behalf


ORDER


