

2016 Diabetes Rx Review Guide

If you or a family member covered under your health plan has a diagnosis of diabetes, knowing the cost of medications can help you make a more informed decision when selecting a plan.

This guide developed by the District of Columbia Department of Insurance, Securities and Banking provides an overview of 24 commonly prescribed drugs to treat diabetes. For each insurance company offering plans for sale on DC Health Link, the charts on the next page depict the name of each drug along with the corresponding drug formulary tier.

Each insurance company uses different language to explain its drug tiering. Reference the charts on the next page alongside your potential plans' Summary of Benefits and Coverage (SBC) to get an idea of your out-of-pocket prescription cost. Generally, the key below the charts displays tiers from least expensive (often generic drugs) to most expensive (often specialty drugs). Once you have identified the drug's cost-sharing tier, use each plan's SBC on DC Health Link to find the actual out-of-pocket cost-sharing of the drug.

In rare cases, a drug on one company's highercost tier (e.g., Non-Preferred Brand) may in fact cost less than the same drug placed on another company's lower cost tier (e.g., Preferred Brand). As you consider different plan options, also check your SBC to see whether your cost-sharing on prescription drugs will apply before or after you reach your deductible.
