**ORDER APPROVING PETITION FOR PAYMENT FROM THE COURT REGISTRY**

On July 30, 2014, D.C. Chartered Health Plan, Inc., acting through its Rehabilitator, Special Deputy to the Rehabilitator and their attorneys (“Chartered”), filed a *Petition for Payment From the Court Registry*. The Petition asked the Court to enter an order approving the withdrawal of \$2,072,770.27 that were deposited into the Court’s Registry on July 1, 2014. These funds were deposited in the Court’s Registry as part of the District of Columbia Department of Health Care Finance settlement and are to be used to make payments on approved claims so as to reach the 83.88% *pro rata* ratio for all claims.

Upon consideration of the Petition and the entire record herein, it is this 5<sup>th</sup> day of August, 2014, hereby

**ORDERED** that the Petition is **APPROVED**, and it is further

**ORDERED** that D.C. Chartered Health Plan, Inc., acting through the Rehabilitator, is permitted to withdraw funds in the amount of \$2,072,770.27 from the Court Registry, and it is further

**ORDERED** that D.C. Chartered Health Plan, Inc., acting through the Rehabilitator, shall make payments to providers in the amounts listed in *In Camera* Exhibit 1 with the funds withdrawn from the Court Registry, and it is further

**ORDERED** that this is entered as a final Order.
