New Business

Eugenia Collis delivered a presentation on the newly funded workplace financial education program: Financially Fit DC @ Work. Key elements of the presentation were:

The State and Local Government Financial Wellness Grants Program is a new national initiative to improve the financial wellness of the public sector workforce with a target population of District of Columbia Government employees, retirees and their families-approximately 60, 000 service recipients

A cross functional team of the Office of the Chief financial Officer, Department of Human Resources and Department of Insurance, Securities and Banking developed the proposal in one month.

The District of Columbia Government was awarded a \$100,000 grant from the National Association of State Treasurers with the District being among 24 awardees out of 135 municipalities to apply

Financially Fit DC @ Work services include Mandatory New Employee Financial Wellness Training, a Comprehensive One Stop Website, Marketing and Employee Engagement, an Education Platform, Group Presentations, and Individual Counseling

The proposal also included information on new and current partner engagement and identified ICMA-RC, Capital Area Asset Builders, DISB Office of Financial Empowerment and Education and Department of Housing and Community Development and DC Housing Finance agency as examples

Projected program benchmarks include Build-Website Development, Pre-Launch-Marketing and Soft Launch with Test Group, Launch-Webinars and Counseling and Post Launch-Survey and Data analysis

Al Pearsall, Ariel Levinson-Wald and Allen Cheaves offered to collaborate with the Financially Fit DC @ Work program.
