Pursuant to the Court's Order of June 23, 2017, petitioner Group Hospitalization and Medical Services, Inc., ("GHMSI") hereby submits a status statement regarding the Petition for Reconsideration and Motion to Stay Further Proceedings ("Petition for Reconsideration/Motion to Stay") that GHMSI filed in the District of Columbia Department of Insurance, Securities and Banking ("DISB") on September 22, 2016, as well as the Motion to Approve Proposed Consent Order that GHMSI filed with DISB on April 17, 2017.

On September 1, 2017, GHMSI notified DISB Commissioner Stephen C. Taylor that it was unable to accept the terms outlined in the Amended Proposed Consent Order that Commissioner Taylor issued on August 3, 2017 (DISB Order No. 14-MIE-26) and that it would continue to pursue its legal remedies with respect to the 2011 surplus review proceedings. *See*

Commissioner.

In light of the continued pendency of GHMSI's Petition for Reconsideration/Motion to Stay, GHMSI respectfully requests that the Court maintain the administrative stay as to the Rebate Order that it issued on June 23, 2017, and continue to hold GHMSI's motion for a stay pending appeal in abeyance. As this Court has directed, GHMSI will transmit to the Court all further DISB orders relating to the pending Petition for Reconsideration/Motion to Stay.
