## SECOND SCHEDULING ORDER

- 1. The Department of Insurance, Securities and Banking ("DISB") shall hold a hearing in this matter on Wednesday, June 25, 2014, beginning at 9:00 a.m., at the Hilton Gardens Hotel, 1225 First Street NE, Washington, D.C.
- 2. Any person or entity (other than Group Hospitalization and Medical Services, Inc. (GHMSI)) requesting (a) status as a party for the hearing, (b) modification of this order, or (c) any modification of standard hearing procedures shall submit a written request to DISB, with citation to legal authority, on or before Friday, May 30, 2014. Such requests shall be no more than ten (10) pages in length. GHMSI may respond to any such request on or before Friday, June 6, 2014. Party status is *not* required for an interested person to submit a report in advance of the hearing, to provide questions for the Commissioner's consideration, or to present testimony at the hearing.
- 3. GHMSI shall submit to DISB a written report for consideration at the hearing no later than Tuesday, June 10, 2014 (i.e., fifteen (15) days prior to the hearing date). GHMSI's report shall not exceed fifty (50) pages in length.
- 4. Members of the public may submit a written report to DISB for consideration at the hearing no later than Tuesday, June 10, 2014 (i.e., fifteen (15) days prior to the hearing date). Such reports shall not exceed fifteen (15) pages in length.
- 5. Persons who wish to testify at the public hearing should notify DISB no later than Friday, June 20, 2014.
- 6. Persons who wish to propose, for the Commissioner's consideration, questions to be directed at the hearing to GHMSI, Rector & Associates, or DC Appleseed, may submit such questions no later than Friday, June 20, 2014.
- 7. The hearing record will remain open until Monday, July 7, 2014 for the submission to DISB of rebuttal or other written statements.
