

5. The Department of Insurance, Securities and Banking (DISB) sent on March 6, 2009, via certified mail signed by Adam H. Levi, Assistant Attorney General and Mary E. Manning, a Notice To Show Cause IB-SC-09-04, to Respondent Kristina P. Johnson, 915 -1/2 North 6th Street, Burlington IA 52601-4912.
6. The Notice To Show Cause/Notice of Hearing sent to Respondent, directed her to appear before the Department of Insurance, Securities and Banking, Suite 701, 810 First Street, NE in Washington, D.C., on April 22, 2009 at 10:00 a.m.
7. After notice was duly given, a public hearing was held on April 22, 2009, for the purpose of determining whether the license of Respondent should be revoked.
8. The Respondent failed to appear at the scheduled Show Cause Hearing or have a representative appear on her behalf.


The certified return receipt for Notice To Show Cause/Notice of Hearing sent to Respondent indicating "return to sender, unclaimed, unable to forward."

FINAL CONCLUSION OF LAW

The evidence and testimony presented by Petitioner's counsel, Adam H. Levi reflected that due notice of the hearing and violation against Respondent was sent to her at her last address of record; that the return receipt indicated it was returned unclaimed; and that Respondent failed to appear at her scheduled hearing. Furthermore, the record also reflected that Respondent in the conduct of her affairs under license No. AI 1004261, violated D.C. Official Code § 31-1131.12 (a)(9) since her insurance producer license was denied, suspended, or revoked in states or territories of the United States, namely, Vermont, South Carolina, Indiana, Louisiana, North Carolina, Ohio, Virginia and Kansas.

FINAL ORDER


