**DEFAULT DECISION AND ORDER OF REVOCATION**

The Hearing Officer enters a Default Decision and Order of Revocation against Respondent, Khalilah A. Hunter based upon the following facts:

1. Respondent Khalilah A. Hunter is licensed as a non-resident producer authorized to transact insurance business in the District of Columbia.
2. Respondent's non-resident producer license number is 2815665.
3. A Notice of Show Cause was sent to Respondent on June 6, 2008 informing her of the charges against her.
4. Violation I of the Department's Show Cause Notice alleged that Respondent in the conduct of "your affairs under the license No. 2815665 violated D.C. Official Code § 31-1131.12(a)(10)(2001) whereby you forged another's name to an application for insurance or to any document related to an insurance transaction." Specification I states that: "On January 24, 2007, you improperly notified Carefirst Blue Cross Blue Shield that Rodney Foxworthy of Progressive Life Center, Inc. had appointed Khaliah Huner d/b/a Hunter Consulting, Inc. as the sole insurance representative with respect to coverage provided by Carefirst Blue Cross Blue Shield, Group #3F78. Rodney Foxworth completed an Affidavit of Forgery dated March 14, 2007 asserting that the document in question was not endorsed or signed by him and that the signature on the said document was a forgery. Specification II states that: "On or about December 10, 2006, you improperly notified Carefirst Blue Cross Blue Shield that Silberstein Insurance Group of Rising Generations Early Life Center would like to appoint Khalilah Hunter d/b/a Hunter Consulting, Inc. as the broker of record for Rising Generations Early Learning Center. Ms. Paulette Munford of Rising Generations Early Learning Center completed an Affidavit of Forgery dated

March 6, 2007 asserting that the document in question was not endorsed or signed by her and that the signature on the said document was a forgery.

5. The Department of Insurance, Securities and Banking sent, via certified mail signed by Lilah Blackstone, Assistant Attorney General dated June 16, 2008, an Official Notice of Hearing To Show Cause IB-SC-05-08, to Respondent Khalilah A. Hunter, 11239 Joyceton Drive, Upper Marlboro, MD 20774 (residence) and 8181 Professional Place, Landover, MD 20785 (business).
6. The Notice of Show Cause sent to Respondent, directed her to appear before the Department of Insurance, Securities and Banking, Suite 701, 810 First Street, NE in Washington, D.C., on July 22, 2008 at 1:00 p.m.
7. After notice was duly given, a public hearing was held for the purpose of determining whether the license of Khalilah A. Hunter should be revoked.
9. The Respondent failed to appear at the Show Cause Hearing or have a representative appear on her behalf.

**ORDER**

Based upon the record and the foregoing facts, **IT IS HEREBY ORDERED** that a **DEFAULT DECISION IS ENTERED** against the Respondent for failing to appear. **IT IS FURTHER ORDERED THAT** Respondent's license No. 2815665 is **REVOKED**.
