CONSENT ORDER EXTENDING ANSWER DEADLINE

WHEREAS on July 5, 2022, respondents Voyager Digital Ltd., Voyager Digital Holdings Inc. and Voyager Digital, LLC (“the Respondents”) filed voluntary petitions for relief under Chapter 11 of the United States Bankruptcy Code and the cases are jointly administered under Case No. 22-10943 before the Honorable Michael E. Wiles in the United States Bankruptcy Court for the Southern District of New York (the “Bankruptcy Case”);

WHEREAS on July 19, 2022, The D.C. Department of Insurance, Securities and Banking (the “Department”) issued a Summary Cease and Desist Order and Notice of Opportunity of Hearing against Respondents (the “C&D Order”) and served the C&D Order on Respondents on the same day;

WHEREAS, pursuant to D.C. Mun. Regs. tit. 26-B, § 304.7, Respondents and the Department jointly agree to extend the time for Respondents to file an answer and request a hearing in response to the C&D Order until thirty (30) days past the occurrence of the effective date of any joint Chapter 11 plan of reorganization of Respondents according to its terms in the Bankruptcy Case;

NOW, THEREFORE, IT IS HEREBY ORDERED THAT the deadline for Respondents to file an answer and request a hearing in response to the Department's Notice is hereby stayed until the occurrence of the effective date of any joint Chapter 11 plan of reorganization of Respondents according to its terms in the Bankruptcy case. Respondents will have thirty (30) days from that effective date to file an Answer to the Notice.
